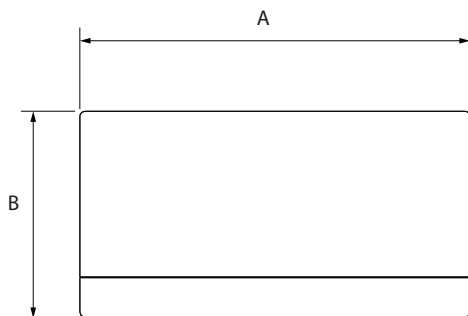

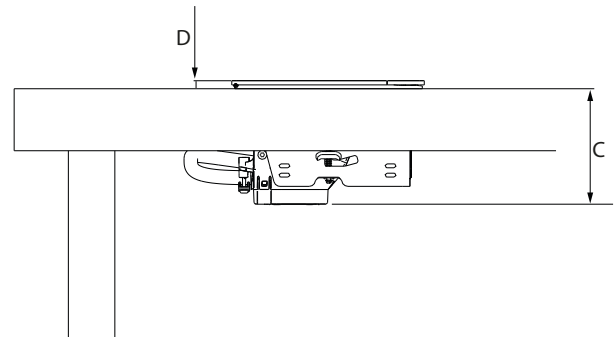

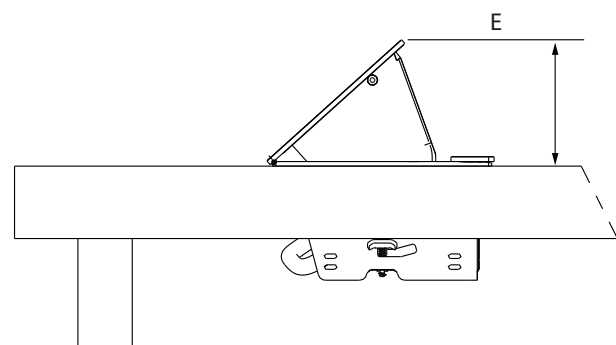

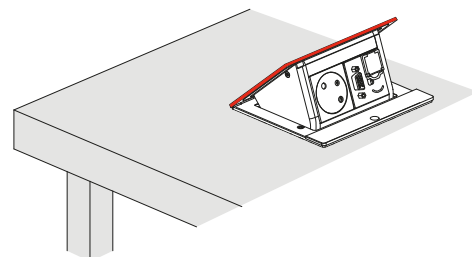
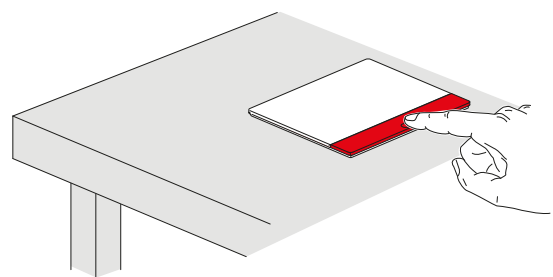
4.1.2 Dimensions under desk
